

Increase participant access to community-based behavioral health services after referral.

Goal: 75% of persons presenting to CRC will be linked to community-based behavioral health services.

Outcome: 99%

Performance Measure #3

Reduce numbers of individuals admitted to a state mental health treatment facility through improved services and care coordination.

<u>Goal:</u> Broward County will experience a minimum 5% reduction in the number of residents being admitted to a state mental health treatment facility.

Outcome: Not Applicable

Performance Measure #4

Increase the number of partnerships formed as demonstrated by formal Memoranda of Understanding/Letters of Commitment, including partnerships about the exchange of information and data related to the target population.

<u>Goal:</u> Two (2) additional partnerships will be formed annually to benefit program participants, as measured by Memoranda of Understanding/Letters of Commitment.

Outcome: 1 Completed; As of Q3 FY 2019-2020 (January-March 2020), The CRS has formed 1 community partnership.

Performance Measure #5

Increase the number of benefit applications submitted by the CRS Benefit Specialists.

Goal: One hundred (100) Benefit applications will be submitted annually to the SSA utilizing the SOAR process.

Outcome: 23 SOAR applications were submitted this Quarter with a total of 57 SOAR applications submitted this year.





Welcome & Introductions

Commissioner Lois Wexler called the meeting to order at 9:30 a.m. Attendance was taken via brief introductions and a sign-in sheet.

I. Review January 15, 2020 Minutes for Approval

Mr. Jack Feinberg made a motion to approve the January 15, 2020 meeting minutes. The second motion was made by Mr. Scott Russell and the minutes were unanimously approved.

II. Utilization Management/ Detox/CSU Report- Jennifer Branham

Commissioner Wexler expressed her concern with Banyan Health Systems and their Care Coordination Team utilization. Ms. Elida Segrera explained that there were changes to the criteria in the DCF Guidance for Care Coordination. The guidance modified the criteria for admission, resulting in the need to discharge some of the Banyan clients earlier than expected. They are now working on increasing the number of clients admitted which will balance the numbers again.

III. CEO Updates



Ms. Silvia Quintana presented the OCP3 Enrollment Policy. Ms. Quintana made the recommendation to have the policy presented to the BBHC's Board of Directors for approval. The first motion was made by Commissioner Nan Rich, and the second motion was made which recommended that the OCP3 Enrollment Policy be submitted to the BBHC Board of Directors for approval.

Ms. Quintana explained that a lapse analysis was completed and funding allocations have been determined. The reallocation of funds was based on the dollars returned by providers that have lapsed, and funds in which the providers have determined that they will not be able to utilize by the end of the fiscal year.

BBHC has proposed to reallocate these funds to providers who will be able to utilize them by the end of the fiscal year.

The proposed reallocation is as follows:

- Broward County Addiction Recovery Center (BARC) received funds for additional TANF beds and Women Services.
- Broward Health received funds for additional crisis beds.
- Henderson Behavioral Health received funds for YouthCase Management.
- Smith Community Mental Health received funds for additional substance use services.
- South Florida Wellness Network received funds for an IPS team and a Care Coordination Peer Navigator team.
- House of Hope received funds for Peer Specialists and additional substance use services.
- The Village South received funds for additional TANF beds.

Ms. Quintana requested the committee's approval to recommend the lapse reallocation of funds be submitted to the BBHC's Board of Directors for approval. On a motion made by Ms. Suzette Fleischman, and second motion made by Mr. Jack Feinberg, the ROSC Committee recommended the lapse reallocation of funds be submitted to the BBHC Board of Directors for approval.

Ms. Quintana mentioned that Fort Lauderdale Behavioral Health provides Transcranial Magnetic Stimulation (TMS) treatment and is available. Transcranial Magnetic Stimulation treatment was developed by the Veterans Administration for individuals with opioid use diagnosis who have had difficulty stabilizing on various medication regimens. The procedure uses highly focused magnetic pulses to stimulate nerve cells in the brain known to affect mood regulation. Currently, there are 20 slots available and providers were encouraged to consider this treatment as an available treatment opportunity within the network.

Ms. Jennifer Branham provided a FASAMS update. Version 14 of FASAMS has been released. At the last Quarterly Provider Meeting, Carisk provided an overview of how the EHR's will look moving forward. The changes are expected to occur between now and August 1, 2020. Carisk will continue to work with providers to ensure their EHR vendor is up to date. Ms. Branham expressed challenges that Carisk is experiencing while testing the system before the expectation of uploading.



Ms. Quintana reported that BBHC is working on a pilot collaboration with Broward Health in Coral Springs, Banyan Health Systems, and the local EMT provider, which would provide Medication Assisted Treatment (MAT) program in that area.

Ms. Quintana reported a meeting was held with the Broward Regional Health Planning Council to restructure their Forensic Team. They are in the process of having their staff re-apply for positions and ensuring the applicants have specific roles and responsibilities and that the individual's qualifications meet those requirements.

Ms. Quintana reported that she was invited by the Children Service Council (CSC) to work on an initiative to visit neighborhoods where there is high violence. The families and the youth of these neighborhoods expressed that they feel like their voices are not being heard.

IV. Suicide Collaborative

Ms. Lois Simpson announced that the Suicide Prevention Coalition is finalizing its strategic plan, which should be published soon. The United Way has identified a mechanism for the data system for psychological autopsies, which would be housed in their SAMHIS system. BBHC will be partnering with the United Way and Broward County to investigate the SAMHSA Grant that was released in which they are hoping to fund an experienced team using the grant. The Behavioral Health Conference will take place on May 12-13. On February 27, 2020 Governor DeSantis announced that February 27th is Florida Suicide Awareness Day and committee members were encouraged to wear green.

V. Provider Advisory Council (PAC) Report

Mr. Paul Jaquith reported that the Child Welfare Care Coordination Teams be structured as the supportive clinical team support once a mother or parent is reunified with her child(ren). The importance for the support and linkage during this time is to assist the mothers who are disengaging from the system, and at a time when parents have a high potential for relapse and additional stressors that tend to occur in the system. Mr. Jaquith stated that the FASAMS pamphlet, 150 update is important for agencies to understand. During the recent Data Workgroup meeting, Carisk expressed the importance of reading the pamphlet thoroughly since it is critical in terms of invoicing moving forward.

I. Consumer Advisory Council Report

Ms. Karen Worthey reported that consumers are continuing to provide outreach to agencies and are conducting the Recovery Self-Assessments. The assessments should be finalized by the end of March 2020.

VI. Centralized Receiving System Report/Presentation

Commissioner Wexler inquired about the number of community presentations that are done monthly. Ms. Pamela Galan reported that Henderson will be hosting the upcoming CIT presentation. Ms. Galan mentioned that Henderson aims to facilitate two presentations a



month. Ms. Galan reported that NAMI Broward will be lending a hand in helping the CRS outreach to local law enforcement agencies.

BRHPC Program Update

o Post-Arrest Diversion Program Update

Dr. Michael Collins presented the Post- Arrest Diversion Program data for January 2020. Ms. Segrera reported that BBHC has been monitoring the new reporting using a newly developed spreadsheet. Concerns about the program were discussed and the possibility of further restructuring was addressed.

Report on Competency Restoration Training (CRT)
 No update was given.

VII. Public Comments

Ms. Suzette Fleischman mentioned that the state has been focusing on the Child Welfare Behavioral Health Integration Initiative, and how great efforts have been made to push this initiative forward. Broward Behavioral Health Coalition has developed a draft version of a form for providers working with the Child Welfare Families.

Ms. Fleischman mentioned that the Department of Children and Families is also working on a pilot with Assistant Secretary, Mr. Rodney Moore, focused on individuals being discharged from The State Hospital who are receiving Medicaid, even after being discharged. These individuals are ready to receive services from Medicaid and would not need to receive assistance from the Managing Entity.

Commissioner Nan Rich reported that the postcard regarding the Census 2020 will be mailed out beginning March 12th through March 20th. Commissioner Rich expressed the importance of every member of the household being counted. The largest undercount in previous years were children ages 0-5. Training continues to be facilitated for case managers and social workers who will be visiting homes to conduct the census. Staff at senior centers have already been trained, since seniors are a large portion of the population in South Florida (420,000 seniors in Broward County). Fifty-six perfcent (56%) of these seniors do not use the internet. The census will be conducted online this year, with secondary options of phone or mail-in responses.
