Tomorrow's Rainbow



Ms. Abby Mosher introduced herself and presented about Tomorrow's Rainbow's mission statement and the services that they provide to children, adolescents, and adults coping with grief and trauma.

Activity/Ice Breaker

Ms. Areeba Johnson presented a video, developed by OCP2, to give an example of the CLAS standards of an individual seeking mental/behavioral health services. Also, as a reminder to providers to ensure their CLC plans are updated.

Updates/New Actions Items:

• CLC Implementation Tool Review

Ms. Areeba Johnson presented the CLC Implementation Monitoring Tool to the providers, reviewed each section, and answered questions about updating the CLC plans.

Telehealth Services

Ms. Johnson led a discussion on how providers will move forward regarding telehealth services now that the CDC guidelines have changed. Providers discussed expanding their telehealth services while also re-introducing face to face services. Clients will be encouraged to use face masks and to get vaccinated.

Mental Health Video and Harmony Development

- Ms. Areeba Johnson presented a video about bullying and how One Community Partnership 3 is providing services to help children in the community cope with bullying.
- Ms. Gabriela Raurell presented about Harmony's various programs that provide services such as counseling, legal assistance, case management, to children and adolescents in the community.
